Lake is Filling

Ice out occurred at the end of February / beginning of March. On March 9, the upper channel was closed by installing the flash boards. The lower gate valve was opened to 1/4 to simulate Spring brook conditions. The lake was 19 inches below the high water mark on March 9, but the lake is filling as the Spring rains continue.

Boater and Swimmer Safety Reminder

Boaters, it is illegal to operate a vessel at more than headway speed within 150 feet of shorelines used as swimming areas for rafts, floats and swimmers. Swimmers, please note that Massachusetts law states that no person shall swim or float more than 50 feet from shore unless accompanied by a boat. Massachusetts water craft regulations also state that no craft may operate faster than 10 miles per hour between the hours of sunset and sunrise. Powered craft must display running lights and unpowered craft must carry flashlight or lanterns.
