Treasurer's Report

A Treasurer's Report dated 6/14/23 showed that the District had \$248,896.30 on deposit. \$101,835.96 was on deposit in the checking account. The report shows 1 deposit of \$8,374.16 from tax collections; 1 deposit of \$66,426.24 transferred from Betterment Account for USDA Loan Payment; and 1 payments of \$134.94 to Mr. O'Coin for document copies made for the Annual Meeting. Of this amount \$84,997.62 was deposited in the Money Market account containing betterment payments. The report shows 1 deposit of \$104.37 from Betterment collections; 1 interest deposit of \$6.84; and the transfer of funds in the amount of \$66,426.24 to the checking account for USDA Loan Payment. The dam stabilization account contains \$60,885.04. The report shows 1 interest deposit in the amount of: \$8.26. \$1,177.68 was in the stabilization account.

Mr. O'Coin is seeking approval for Warrant #253. A motion was made by Mr. Carr and seconded by Mr. Waterman and voted unanimously.

Tax Payment & Betterment Payment Updates

92 proprietors pay tax to the District. Mr. O'Coin reported 78 paid partially, 11 paid in full. To date, ~77% of annual taxes have been collected. There have been no other betterment payoffs. 45/48 paid in full 97% of planned collections to date.

Old Business

Lake Clarity & Level Management Update

Mr. Waterman reported lake clarity has improved over the past few days from the pollen accumulation. Lake levels are typical for this time of year.

Mr. Carr reported he has observed a different water vegetation he has not noticed before. He described the leaves curling like a banana.

Dam Maintenance and Dam Crest

Sunshine Landscaping has been contracted for the 2023 season for mowing. Follow up on the mowing schedule.

Weed Treatment & Water Quality Monitoring

The Management Committee reported no changes or updates to report at this time.

New Business

The Management Committee discussed recirculating "Boater Safety Reminders" to the proprietors via social media. A copy of the Boater Safety reminders were distributed to all proprietors with the warrant for the annual meeting in May.

Executive Session

The regular meeting of the management committee was not recessed for an executive session.
