CEDAR MEADOW LAKE 2010 - 2011 ACTION PLAN STATUS REPORT

GOAL 1. DAM MAINTENANCE

Maintain the dam in good condition and provide the ability to engage in periodic draw downs or other actions to maintain the lake in good condition. Routine maintenance will include monthly mowing of the upper dam surface.

Responsibility: Management Committee with assistance of qualified contractors

Resources: Funds in Annual Budget

GOAL 2. TREE REMOVAL

Continue to seek access to the property on the south side of the dam to cut large trees within 15 feet of the dam structure as ordered by the Office of Dam Safety.

Responsibility: Management Committee

Resources: Funds contained in the Annual Budget

Raymond Shea, Jr., the owner of the land below the dam continues to refuse the District access to this land to cut trees.

GOAL 3 REPAIR DAM

Continue to find and stop the leaks in the dam through hand packing with concrete. Coordinate dam repairs with the annual draw down if possible.

Responsibility: Management Committee with assistance of volunteer divers, and volunteer workers

Resources: Funds contained in Annual Budget

Borings were made in the crest of the dam and concrete poured into these opening to fill voids in the dam core. Two leaks were stopped, but additional leaks have developed.

GOAL 4. WEED CONTROL

Draw down the lake five feet beginning in late September or early October and maintain this water elevation until the lake bottom freezes for weed control purposes. Thereafter, efforts will be undertaken to maintain lake levels between 30 and 36 inches below the spillway elevations during that portion of the winter when the lake is covered with ice to minimize ice damage to shoreline structures.

Responsibility: Management Committee

Resources: Volunteer hours and minor administrative expenses

Heavy rainfall in the Fall and early Winter prevented dropping the lake water level more than 36 inches. Similarly, rain, snow and ice melt in March prevented keeping the ice and water levels down to goal levels.

Continue to implement a program to solicit voluntary contributions from non-Proprietor neighbors that might use or otherwise enjoy the lake.

Communicate information regarding happenings on and around the lake through periodic newsletters and the District's web site www.cedarmeadow.org.

Responsibility: District Clerk
